# **Vulnerable Adults and Elders at Risk of Abuse, Neglect or Exploitation**

**For elders age 60 & older: Call the Dept. of Social Services at 746-2300**  
**For adults age 18 - 59: Call the Dept. of Community Programs at 746-2345**

If you are concerned about an adult of any age who you believe may have experienced, be experiencing or be at-risk-of experiencing some form of abuse or neglect, you are urged to report this concern.

◆ ***Physical Abuse:***

The intentional or reckless infliction of bodily harm on an individual

◆ ***Emotional Abuse:***

Intimidating, threatening, humiliating or otherwise harassing an individual for no legitimate purpose

◆ ***Sexual Abuse:***

The forcing of unwanted sexual activity onto an individual, by the use of threats, coercion or other means

◆ ***Financial Exploitation:***

Obtaining an individual's money or property through deceit or enticement or by forcing, compelling or coercing the individual against his/her will or without his/her consent

◆ ***Neglect:***

The failure of a caregiver to secure or maintain adequate care, services or supervision for an individual, including food, shelter, clothing, physical or mental health care, that creates significant risk or danger to the individual's physical or mental health

◆ ***Self Neglect:***

An individual's failure to take adequate care of self or home, including failing to obtain appropriate food, clothing, shelter, medical and dental care, that results in a significant danger to his/her physical or mental health

◆ ***Treatment without Consent:***

The administration of medication or the performance of psychosurgery, electroconvulsive therapy or experimental research on an individual who has not given informed consent

◆ ***Unreasonable Confinement or Restraint:***

The intentional confinement or separation of, use of physical restraints on, or provision of unnecessary or excessive medication to an individual

## **EDUCATIONAL OPPORTUNITIES**

## **HEALTH CARE**

- ◇ **Asera Care Hospice** — This agency provides medical, psychological and spiritual support to patients facing terminal illness and their families. Services are often covered by Medicare or Medicaid and can be provided in a patient's home or in an assisted living facility, hospital or nursing home. Each patient is served by a team of professionals including physicians, nurses, home care aides, social service and spiritual personnel. Volunteers also play an important role. Based in Green Bay, this agency serves Door County on a case-by-case basis.

- ◆ **Red Cross Transportation Service** — Provides transportation to medical appointments, nutritional, educational, employment, social & recreational outings at minimal cost. Trained volunteer drivers provide rides both in Door County and to/from Green Bay on a regular schedule. Medical appointments are given priority when scheduling. Door County residents with a disability or those who are age 60 or older are eligible for this service.
